Membership dues schedule

For applications approved between October 1 through June 30:

\$215 USD (\$195 annual dues, plus one-time \$20 application fee) **Student:** \$25 USD (\$20 annual dues, plus one-time \$5 application fee)

For applications approved between July 1 through September 30: (membership expires on December 31 of the current year)

\$118 USD (\$98 half-year dues, plus one-time \$20 application fee) Student: \$15 USD (\$10 annual dues, plus \$5 application fee)
